****MEETING BEGINS AT WWTP, 3040 MILL CREEK RD., BOONVILLE, NY 13309 AT 7PM.****

Present: Mayor Dellerba, Trustees Brach, Satterly, Stabb, WWTP Foreman Lucas Kafka, Treasurer Kaiding and Clerk Lee. Absent: Trustee Stanford. Visitors: Erin Ryan, PE and Jesse Semanchik, PE for Barton and Loguidice; Tyme Ferris, Chairperson, Megan Pfendler, Secretary and Sherry, Member - all of the Boonville Environmental Conservation Council (BECC).

Mr. Semanchik and Ms. Ryan discussed the future upgrades to the WWTP and the Mill Creek interceptor. Such upgrades including, but not limited to: renovating the headworks with mechanical fine screen, replacing grit equipment, SBR – installation of (2) new tanks to batch reactor, retro-fitting the clarifier, new concrete tanks, installation of a UV disinfection unit in the clarifier, new blowers, new treatment tanks, and repairs to the interceptor: manhole repair or replacement, (1 manhole is cleaved in half), installation of cured-in-place (CIP) pipe lining, and replacement of the concrete surrounding the pipe; for increased protection. A large focus will be placed on the updating of the disinfection system; the Village's discharge permit has not been updated since the 1970's. The ammonia limits have dropped.

Foreman Kafka then proceeded to tour the group around the facility and field questions regarding the operation of the WWTP.

The group exited the WWTP at the conclusion of the tour and the Village Board members, Treasurer Kaiding, Clerk Lee and BECC Chairperson Tyme Ferris, returned to the Village Offices to continue the rest of the workshop meeting.

Present: Mayor Dellerba, Trustees Brach, Satterly, Stabb, Treasurer Kaiding and Clerk Lee. Absent: Trustee Stanford. Visitors: Tyme Ferris, Chairperson of the BECC.

Meeting: Mayor Dellerba called the meeting to order at 8:07 PM with the Pledge of Allegiance.

Minutes: Motion by Trustee Brach, seconded by Trustee Satterly to approve the special meeting minutes of May 31, 2023 and the regular meeting minutes of June 13, 2023 as presented. Ayes — Trustees Brach, Satterly, Stabb and Mayor Dellerba; nays — none. Motion carried.

Visitors: <u>Tyme Ferris – BECC-</u> Mr. Ferris spoke regarding the BECC, Inc.'s acquisition of their own tax ID number to separate them from the Village of Boonville. The council has also been supporting the Boonville Community Harvest Farmer's Market.

NYS DOT- Office of Right of Way- An official Notice of Appropriation and map were received in accordance with Section 502 of the Eminent Domain Procedure Law regarding a small parcel along Park Avenue.

<u>Email – NYS Public Service Commission-</u> A notice of petition was received regarding the: Institution of a Proceeding to Investigate and Evaluate Options for Making Additional Central Office Codes Available in the 315 Area Code Region.

New Business: <u>Disability Insurance-</u> An email was received by Treasurer Kaiding from Reina Pritchard of the Municipal Commission regarding the idea of an increase in the NYSIF Disability contribution by employees to increase the amount of benefit coverage, above the statutory benefit level. No action was taken at this time.
