2024 Dental and Medicare Supplemental Insurances- The current dental plan that the village employees subscribe to will have a 3.8% increase in premiums for 2024. Village employees must pay for their dental insurance in full. The new premiums for 2024 are listed:

The 2024 Medicare Blue PPO 2 premium rate reflects a \$0.14 decrease over the 2023 rate. The village retirees pay 20% of the monthly premiums on the Medicare supplemental plan and the village pays 80%.

A motion was made by Trustee Stabb, seconded by Trustee Brach to approve of the new 2024 dental and the 2024 Medicare Supplemental premium rates as presented. Ayes - Trustees Stabb, Brach, Stanford, and Satterly; nays - none; abstains - Mayor Dellerba. Motion carried.
