<u>Thank you note-</u> A note of thanks was received from the BYAA for all that the Village of Boonville does to assist them with the BYAA sports complex.

#### **New Business:**

<u>Monthly Treasurer's Report-</u> Treasurer Kaiding sent the September treasurer's report to the board ahead of the meeting. A motion was made by Trustee Stabb, seconded by Trustee McIntyre to approve of the September treasurer's report as presented. Ayes – Trustees Stabb, McIntyre, Andrews, Satterly and Mayor Dellerba; nays – none. Motion carried.

<u>Antler Ridge-</u> The Chamber of Commerce has an annual contract with Antler Ridge to provide the reindeer in Little Village Park for the Christmas season. The contract, with the amount of \$4,100.00, is inclusive of reindeer feed. After some discussion, a motion was made by Trustee Stabb, seconded by Trustee McIntyre to donate \$1,600.00 to Antler Ridge as partial payment of the Chamber of Commerce's 2025 reindeer contract. <u>Barton & Loguidice Contract for WWTP Capital Project-</u> Amendment #6 of the Barton & Loguidice service contract for the WWTP Capital Project shifts the unused budgets, a total of \$74,000, to the Task D Construction Phase Services. There is no additional cost to the Village with the no cost fee shift. A motion was made by Trustee Stabb, seconded by Trustee Andrews to approve of the mayor's signature on the contract for Amendment #6. Ayes – Trustees Stabb, Andrews, McIntyre, Satterly and Mayor Dellerba; nays – none. Motion carried.

<u>Civally Contract-</u> A web site design and service contract was presented to the board for review. If the contract is approved, the newly constructed web site will be migrated to a .gov domain (state mandate), able to have online payment features for building permits, pavilion rentals, and Lot B parking ticket purchases, The web site will also be ADA compliant (federal mandate by 2027). After some discussion, a motion was made by Trustee Stabb, seconded by Trustee McIntyre to approve of the Civally contract and to pay the one-time construction fee of \$5,000 from the contingency line item. <u>Civally online payments feature-</u> A motion was made by Trustee Andrews, seconded by Trustee McIntyre to approve of "Stripe.com" as the online payment system to be integrated with the new website.
