- Excavation of existing curbing by contractor
- Old curbing and other construction debris to be removed by contractor
- Contractor to provide and install 1,800 linear feet of 6" x 18" Class J concrete curb on new 6" stone subbase consisting of compacted of crusher run stone
- Curing and sealing of concrete by contractor
- Contractor to backfill disturbed areas with proper material and restore all construction-disturbed lawns and driveways
